All payments must be made in full. You authorize Goathead Records to charge your provided payment method for services and any applicable fees. Failure to maintain valid payment may result in suspension or termination of services.

8. Non-Resale and Confidentiality

You agree not to distribute, replicate, or resell any proprietary Goathead Records materials, including watermarked files,
